1. REQUIREMENT OF TRAINEE ENGINEER-I :

NOTE: Relaxations & Concessions will be applicable to candidates belonging to OBC-NCL/ST/PwBD as per Government directives.

AGE AS ON 01.06.2026: The upper age limit will be relaxable for ST candidates by 5 years and for OBC candidates by 3 years. Candidates belonging to Persons with Benchmark Disability (PwBD) category having minimum 40% disability or more will get 10 years' age relaxation in addition to the relaxation applicable to the categories mentioned above. SSLC/SSC/ISC Marks Card or any other valid document will be considered as proof of Date of Birth.

2. TERMS OF ENGAGEMENT & REMUNERATION:

- Trainee Engineer-I** will be engaged for an initial period of 2 years, which may be extended up to maximum of ONE YEAR (Maximum tenure of 3 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs.30,000/- per month for 1st year, Rs.35,000/- per month for 2nd year and in the event of extension of contract Rs.40,000/- per month for the 3rd year.
- In addition to the remuneration indicated above, a consolidated amount of Rs.12,000/- per year will be paid towards expenses like insurance premium, attire allowance, stitching charges, footwear allowance etc. The additional amount shall be paid in two installments. First installment will be processed in the first month's salary after joining and the second installment will be paid on completion of 6 months from the date of joining.
- Advancement to Project Engineer-I:** Once the candidate has completed two years as Trainee Engineer, he/she will be eligible for advancement to Project Engineer-I subject to fulfilling the following criteria:
 - Performance Assessment scores as Trainee Engineer should meet the criteria of 80% and above marks for both year (aggregate);
 - Attendance (>80% during preceding 1 year) and General Discipline must be good;



iii. Trainee Engineer must not have any adverse remarks against him/her in the preceeding 2 years.

Trainee Engineer failing to meet the above criteria will continue as **Trainee Engineer-III for further one year**, subject to requisite approval. The period of engagement will come to an end on completion of one year in such case.

- d) Post advancement to Project Engineer-I, the engagement shall be for a period of 3 years which may be extended upto a maximum of One year based on project requirement and performance of the Project Engineer with due approval of the competent authority.
- e) **Retention Bonus for Project Engineers:** Project Engineer who have advanced from Trainee Engineer role will be entitled for Retention Bonus of Rs.25,000/- for every completed year, provided that he/she complete overall tenure of 4 years in Project Engineer role. However, the retention bonus will be calculated for the tenure in Project Engineer role and will be payable at the end of 4 years i.e., Rs.1,00,000/-.

Note:

- B.E./B.Tech/B.Sc Engg (4-year course) with **PASS CLASS** from a recognized University / Institution in the relevant discipline are eligible.
- Candidate must possess all years / semester marks sheet and degree certificate. In case of CGPA grading, conversion certificate to substantiate the claim shall be attached and has to be indicated in the application form.
- Only the above mentioned branch will be considered relevant.

4. SELECTION PROCESS & MODE OF SELECTION:

- Candidates meeting the stipulated eligibility criteria specified in the advertisement, will be called for Written Test and candidates shall be selected in the order of merit i.e., category-wise, discipline-wise. The written test shall be conducted for **100 marks**.
- The minimum qualifying marks required for suitability for different categories of candidates are as under:

- The question paper will include **negative marking of 1/4 mark** for each wrong response.

- a) SSLC/SSC/10th Standard marks card or any other valid document as proof of Date of Birth.
- b) B.Sc (Engg. - 4yrs)/B.E./B.Tech Engineering Degree Certificate (as applicable), **clearly indicating the discipline and class obtained.**
- c) All semester marks cards or consolidated marks card.
- d) CGPA Conversion document (Wherever applicable).
- e) Caste / Tribe / Community / Disability / Economic status certificate in case of candidates belonging to SC / ST / OBC (NCL) / PwBD / EWS respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format.
